Sub:- Recognition of school from 1.8.80 for classes I to X.

Madam/Sir,

In reference to the correspondence resting with this office on the subject noted above. I am to convey the orders of the D.D.E. (South) regarding the recognition of your school w.e.f.1-5-80 subject to the fulfilment of the following conditions from classes I to Xth and subject to Court/Judgement/stay/injunctions if any,

1. The Management shall put in sessions efforts to get the suitable land for the school.
 2. The Management shall ensure that it has adequate funds to meet its financial responsibilities for regular payment of salary and allowances to its employees.
 3. The Management shall ensure that the accommodation and sanitary facilities as well as all requisite accommodation is provided to the institution keeping in view, any other facts age and number of pupil's attending it.
 4. The Management shall employ teachers with prescribed qualifications only.
 5. The school shall employ teachers as per norms/yearstick of pupil teachers ratio.
 6. The school shall not run for the profit of any individual, group or association of individual or any other person.
- Admission to the school shall be opened to all without any discrimination of religion, caste and place of birth.
8. The Managing Committee shall observe the provisions of Delhi State Education Act/Rules 1978.
 9. The building and other construction in which the school is carried, its surroundings furniture and equipment are adequate and suitable for an educational institutions keeping in view the number of the pupils and subject taught in the school.
 10. The building and other structures as the grounds of the school shall not be used during the day or night for commercial/political or non educational activities.

11. The facilities prescribed under Rule 57 shall be made available to the institution.
12. The services of the unqualified members of the staff may be got regularised.
13. Members of the staff should be appointed in accordance with the minimum qualifications laid down by the Department and those who are without having qualifications should be asked to qualify themselves within two years.
14. Service contract between the Management and the employees should be executed immediately.
15. That the school Management shall procure the land for the school by 30.4.81 and start the construction of the school building.
16. The Management shall require all the requirements prescribed by the Education Department, Delhi.
17. The school building and premises be got transferred in the name of the parent body of the school. If there is any Court verdict against the school Management regarding the ownership of the building and the premises, the recognition shall lapse.
18. Science material worth Rs.5000/- and sports material worth Rs.5000/- be purchased separately.


