(South) regarding the recognition of your school wee.f.1-5-80 subject to the fulfilment of the following conditions from classes I to Xth and subject to Court/Judgement/stay/injunctions if any.

- The Management shall put in sessions efforts to get the suitable land for the school.
- The Nanagement shall ensure that it has adequate funds to 2. meet its financial responsibilities for regular payment of salary and allowances to its employees.
- The Management shall ensure that the accommodation and 8. sanitary facilities as well as all requisite accommodation is provided to the institution keeping in view, any other facts age and number of pupil's attending it.
- The Management shall employee teachers with prescribed 4. qualifications only.
- 5. The school shall employes teachers as per norms/yarostick of rupil teachers ratio.
- The school shall not run for the profit of any individual, 6. group or association of individual or any other person.

Adrigation to the school shall be opened to all withour any discremination of religion, caste and place of birth.

- The Managing Committee shall observe the provisions of Delhi 8. State Education Act/Bules 1978.
- The building and other construction in which the school is 9. carried, its surrondings furniture and equipment are adequate and suitable for an educational institutions keeping in view the number of the pupils and subject taught in the echool.
- 10. The building and other structures as the grounds of the school shall not be used during the day or night for commercial/political or non educational activities.

- The facilities prescribed under Rule 57 shall be made 11. available to the institution.
- The services of the unqualified members of the staff may 12. be got regularised.
- Members of the staff should be appointed in accordance 15. with the minimum qualifications Isid down by the Department and those who are without having qualifications should be asked to qualify themselves with in two years.
- Service contract between the Management and the employees 14. should be executed immediately.
- That the school Management shall procure the land for the 15. school by 30.4.81 and start the construction of the school building.
- The Management chall requires all the requirements pres-cribed by the Education Department, Delhi. 16.
- The school gilling and premises be got transferred in the name of the parent body of the school. If there is My any Court verdict against the school Management regarding 17. the ownership of the building and the premises, the recognition shall lapse.
- 18, Science material worth Rs.5000/-and sports material worth Rs.5000/-be purchased seprately.
