
OCCUPANCY CERTIFICATE

With reference to your notice of completion dated 15.12.03, I hereby certify that the building as per description below certified plans of Sr. Secondary School School for Lott Carey Misson in India, 5, Ansari Road, Darya Ganj, Delhi at Vasundhara Enclave, Chilla Dallupura, Delhi, whose plans were sanctioned/released vide No. .F.13(55)/97/Bldg./13 dated 8.1.98 has been inspected with reference to Building Bye-Law in respect of the structural safety, fire safety, hygienic and sanitary conditions inside and in the surroundings and is declared fit for occupation.
